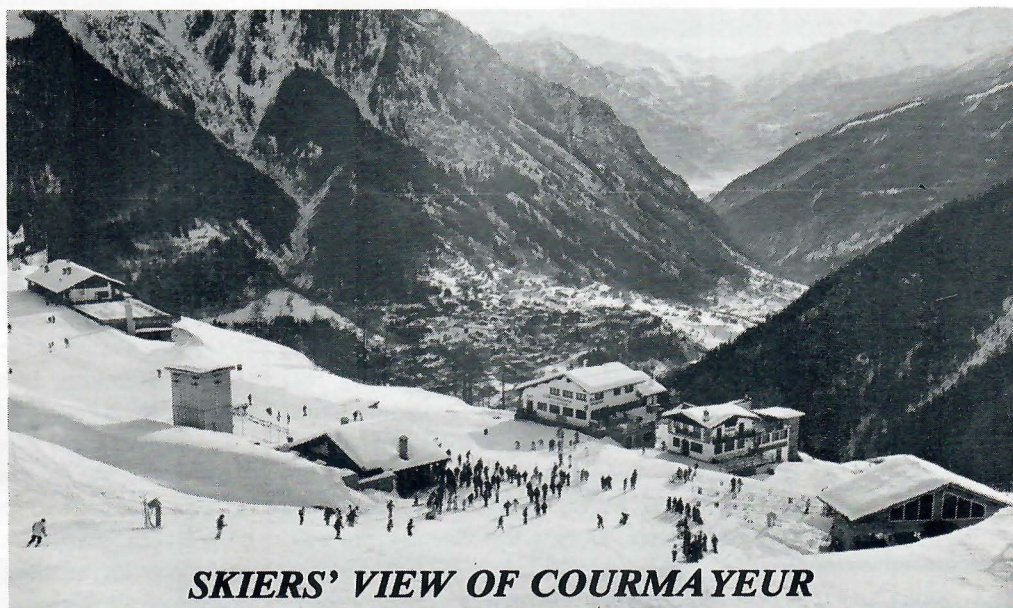

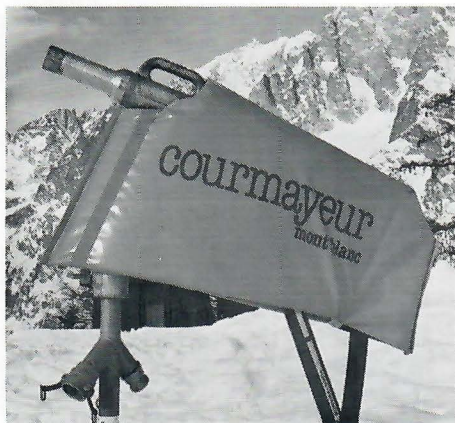
CONTEST WINNER

PEACE IN THE ALPS

"Good Guns"

Three days following the outbreak of war in the Persian Gulf, the Texas Expedition departed for the peace and serenity of Courmayeur in the Italian Alps. Many of the participants chose not to risk the uncertainty of international travel and remained home. There were 10 left - 10 members of Clear Lake Area Ski Club and Space City Ski Club who chose to take the risk of traveling for the joys of skiing.

These folks really wanted to go skiing. And what a ski trip they got. Seven sun-filled clear days of mild temperatures, abundant snow, and breathtaking scenery of the Mount Blanc range, the Matterhorn, and the Aosta valley.

Trip leader Marilyn Anderson (CLASC) bid her merry band farewell at the airport, entrusting their fate to Dick Howard (SCSC) who was called up from the reserves the previous day to lead both the CLASC/SCSC group and to coordinate the Expedition events for the Texas Ski Council.

Getting there was not half the fun. Additional security and check-in procedures consumed all available time during plane changes in New York. It was difficult to know who was more confused, the passengers or the security personnel. Gunter Sabionski (CLASC) found a way to beat the system and was always the first one to get to the plane throughout the trip. The complimentary wine and beer on the Alitalia flight to Milan helped soothe any frayed nerves and assure a restful transatlantic crossing.

Once in Italy and the comfort of the Hotel Perrier Monte Bianco, the news of war could be forgotten if one preferred. One local cafe did carry CNN for those who wanted to stay informed in English. The group was greeted by Ralph and G. P. Montijo (CLASC) who had preceded the group by one week to ski at Chamonix. They were relieved that someone showed up and so was the hotel staff - business was slow that week.

The first order of business while in Italy is of course to eat. And eat they did - excellent food all week. Sue Shirley's (SCSC) computer translator was a constant source of amusement throughout the week as it attempted to translate the dinner menu and thoroughly confuse the patient and good-humored dining room staff.

But this was a ski trip, so let's talk skiing. Courmayeur is a high altitude village located at the end of the Aosta Valley on the Italian side of Mount Blanc opposite the French resort of Chamonix. If you think European ski

slopes are icy, ungroomed, poorly marked, and served by antiquated T-bars - guess again, Bubba. Courmayeur has a modern lift system of cable cars, gondolas, and chairs and, get this, the most extensive snowmaking in Europe with a fleet of Snowcats to groom to perfection. Ask Lee Swords (SCSC). This was the best snow he had ever seen. It was also the first snow he had ever seen. Lee was

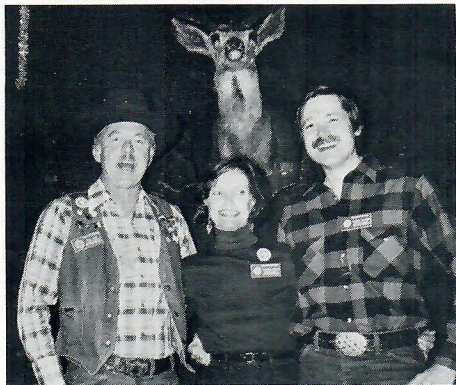

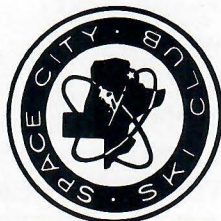

I am aware that SCSC carries no insurance nor maintains a reserve for liability.

I wish to participate on this trip or activity because SCSC provides me with the economics and discounts of group purchasing power, social interaction with compatible individuals, and does all the planning and reservation work for me.

In consideration of the above, I, for myself, my heirs, executors and assignees do hereby release and discharge SCSC, its directors, officers and any other person appointed by them, from all claims, damages, demands or actions whatsoever in any manner arising from my participation on this trip or activity. I agree that I am solely responsible for my personal safety and conduct. I also agree to indemnify and hold harmless SCSC, its directors, officers and agents, or contractors from any loss, cost, or expense, incurred by, or attributable in any way to me, in connection with this trip or activity.

I also certify that I have read, that I understand, and that I agree to abide by, all the Bylaws and Standing Rules of SCSC. I understand that payments made for trips or activities may not be refundable, in whole, or in part, and that all payments will be handled in accordance with the applicable provisions of the Bylaws and Standing Rules.

I hereby appoint SCSC, its directors, officers and agents, as my agent to perform all acts and to enter into, any, and all contracts as may be deemed desirable in connection with this trip or activity. I understand SCSC acts only as coordinator and accepts no responsibility for the services of any person, ski area, resort, airline, motor coach, hotel or any organization whatsoever rendering any of the services or accommodations being offered on this trip or activity. Trip and activity fees are based on current tariffs and are subject to change without notice. SCSC accepts no responsibility, in whole or in part, for any delays, delayed departures or arrivals, missed plane or other carrier connections, loss, damage, or injury, to person or property, mechanical defect or failure of any nature, however caused, or for any substitution of hotels or common carrier, with or without notice, or for any additional expenses occasioned thereby.

APPLICABLE STANDING RULES OF SPACE CITY SKI CLUB, INC.

5.0 TRIP PENALTIES

5.1 If a trip participant withdraws from a trip after the specified date, the trip participant will lose his entire payment unless he or she can be replaced from the waiting list, or the Trip Coordinator is able to recover some or all of the participant's costs by cancellation of lodging, transportation, and/or other commitments. The trip participant will be entitled to the entire amount recovered by replacement or cancellation of arrangements less the cancellation fee stipulated in Section 5.2 of these Standing Rules and any extra expenses incurred by the Club in cancelling any of the previously made arrangements. The trip's profit or loss will not be a factor in determining the exact refund due. Also, if the Trip Coordinator failed to exercise a reasonable effort in cancelling accommodations or finding a replacement, the Executive Committee will award the refund, less the cancellation fee.

5.2 CANCELLATION FEES.

- A. A participant may forfeit his full deposit if he fails to notify the Club in writing of his intent to withdraw prior to the published final payment dates. A minimum charge of \$10 will be assessed for each trip cancellation, and such charges will be increased by \$5 per calendar month for each additional calendar month or portion thereof the participant's reservation is held prior to cancellation. Cancellation fee, however, may not exceed the amount of the trip deposit.
- B. A participant cancelling from more than one trip shall be charged \$25 in addition to the calculated cancellation fee for each cancellation subsequent to the first cancellation.

5.3 A charge of \$5.00 will be assessed for each trip transfer made prior to final payment date. A transfer will not be considered after final payment date unless a replacement can be secured.

5.4 Deposit, transfer and cancellation charges for non-domestic trips shall be determined by the Executive Committee and included in the trip release form as well as in all trip publicity; in no case shall these requirements be less than those provided in Sections 5.2 and 5.3 of these standing Rules.

7.0 RESTRICTIONS.

- 7.1 Allowing non-trip participants to occupy any room as a non-registered guest is strictly prohibited, and in violation of Club policy and subjects the member to disciplinary action.
- 7.2 The illegal use of controlled substances during Club trips, or on any other official Club function, is in violation of Club policy, and is strictly prohibited.
- 7.3 No substitutions of trip participants shall be allowed without the knowledge and approval of the Trip Coordinator, and new additions to the trip shall come from that trip's Waiting List. The Trip Coordinator shall make all substitutions.
- 7.4 It is the policy of the Club not to allow the active solicitation of the general membership at a Club function or in the Club publication for any other than Club sponsored trips or activities without the consent of the Executive Committee.
- 7.5 No person may participate in a Club sponsored trip, or participant paid activity, without first completing a written and signed Release of Liability for that trip or activity, on a form approved by the Board of Directors.

8.0 MISCELLANEOUS.

8.1 SKI TRIP SIGN UP

- A. No member shall be allowed to sign up for any ski trip prior to the September General Meeting except as designated by prior approval of the Executive Committee.
- B. Each member may sign up for him/herself and one other member on any ski trip or ski trip waiting list.

8.2 **WEATHER.** If a trip should be "weathered-in" the additional lodging expense will be left up to the individual, although the Trip Coordinator will assist in making accommodation arrangements, and collection for same shall be left up to the lodge.

8.3 **NON-SKI TRIPS/ACTIVITIES.** Reservations for participation in such activities may require full payment, instead of a deposit fee.
