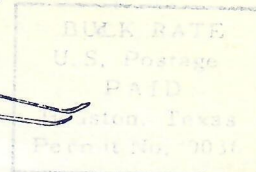
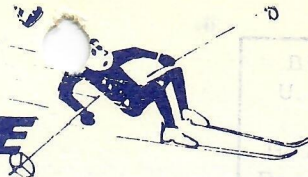

GROUND RULES

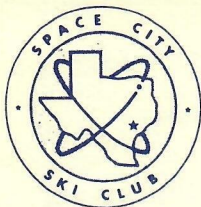
1. In the Club at the Racetrack, coats for men and dresses for the damsels.
