Three full days of skiing at rock-bottom cost.

Total Cost of \$55.00 -- includes: Round-trip bus transportation, local transportation, accommodations at the HIGH COUNTRY INN (4 per suite), two wine and cheese parties.

Additional Costs:

Equipment rental (skis, boots, poles - reserved by Club) . . \$12.00 (Equipment and clothes may be rented at Village Sporting Goods)

Lift tickets - per day, \$5.50; two days, \$9.50; three days, . . \$15.00

Group Lessons - per person, per day \$6.00

Plus, your own meals and entertainment while in Ruidoso

The bus will leave at 5:30 PM, Thursday, January 19th from the Parking Lot of Briargrove Center, 6200 Westheimer, to return Monday morning, January 23rd - in time for work. PLEASE BRING YOUR OWN FOOD, REFRESHMENTS AND SETUPS for the trip -- the Club will furnish ice.

DEPOSIT POLICY:

Your reservation is entered when your deposit of \$30.00 is received by the trip Co-Chairman. It is refundable unconditionally if you cancel your reservation on or before January 8th, by calling or writing the Co Chairman. The balance of the trip cost of \$25.00 (\$37.00 if you rent equipment through the Club), is due on or before January 7th. If you cancel after January 8th, the money you have paid will be refunded after the trip IF YOUR PLACE IS FILLED FROM A WAITING LIST or, IF THERE IS NO WAITING LIST, IF YOU PRODUCE A REPLACEMENT.

EQIUPMENT RENTALS:

If you do not have full ski equipment, you can rent skis, poles and/or boots either in Ruidoso or Houston.

The advantage of renting in Houston is that you have ample time to select equipment that fits you properly. The advantage of renting in Ruidoso is that the Club will reserve equipment for you and it will be waiting at the High Country Inn, relieving you of carrying it there and back.

In Ruidoso, skis, boots and poles are \$12.00 for three days. In Houston, rentals are a little less at Village Sporting Goods. Village Sporting Goods also rents ski clothes.
